I-70 West Bound

Exit at the Fourth Street Exit, take a right onto Fourth Street, travel several blocks, take a left onto State Street. Cross over High Street and take a right onto Front Street. You will see the Doubletree Guest Suites Hotel just ahead on the right. Just past the Hotel is Capital Alley, take a right onto Capital Alley and turn immediately into the Garage.

I-70 East Bound

Exit at the High Street/Front Street Exits. Take a left onto Front Street and go approximately five or six blocks. Just past State Street is the Doubletree Guest Suites Hotel. Just past the Hotel is Capital Alley, take a right onto Capital Alley and turn immediately into the Garage.

I-71 North Bound

Take I-71 north to I-70 east; stay in the right lane. Follow the directions for I-70 East Bound.

I-71 South Bound

Exit at Broad Street and take a right onto Broad Street. Continue several blocks, you will pass the Capital Building (on your left) and cross over High Street. Before you come to the next light, you will see Wall Street on the left. Take a left onto Wall Street (you will see the garage ahead on your right). Take a right on the first side street (Capital Alley) and turn immediately left into the garage.

On Foot from High Street

When you enter the Huntington Center, take the escalators up one level. Pass through the first bank of elevators and go through the revolving door. Take this bank of elevators to the 7th floor. The front desk is through the first set of glass doors on the right side.
